

# TERMS OF AGREEMENT/CONTRACTUAL RULES

#### 1. INDEMNITY AND LIMITATION OF LIABILITY

Except for negligence or willful misconduct, neither GGLLC, member, any co-member, meeting facility, or other exhibit space provider, nor any of their officers, agents, employees, facilities, other representatives, or assigns shall be liable for, and are hereby released from, any claims for damage, loss harm, or injury to the person, property or business of the parties or any of its visitors, officers, agents, employees, or other representatives, resulting from theft, fire, earthquake, water, unavailability of the exhibition facility

or intermediate staging facilities, accident, or any other reason in connection with the forum or any planning meeting, demonstrations, or stagings. The Member and GGLLC (as the "Indemnifying Parties") shall indemnify, defend, protect and hold the other (the "Indemnified party"), their officers, directors, agents, and employees, harmless from: any and all third-party claims, demands, suits brought or threatened; damages, losses, costs, reasonable attorneys' fees and expenses which result or arise from negligence or willful misconduct in connection with the Indemnifying Party's participation in the forum, provided that

(1) the Indemnified Party gives prompt notice of the claim to the other party; (ii) the Indemnifying Party has sole control over the defense of the claim, including any decision to settle; and (iii) the Indemnified Party provides the other party with all reasonable assistance therein.
